B. Assessment and Certification

To assess and certify the competencies of the trainees, assessment process is done to confirm that graduates can perform the standard expected in the workplace based on the defined competency standards. Certification is awarded to graduates who meet the competency standards.

TESDA has a Registry of Certified Workers which provide information on the pool of certified workers for certain occupations nationally.

SSVTC is an accredited assessment center in Oriental Mindoro with competency accredited assessors who conduct competency assessment process for individuals applying for certification.

C. OJT and EMPLOYMENT FACILITATION

A practical training on the job in the industries which supplements actual knowledge for a period specified in the Training Regulations. The institution assists the graduates in finding prospective employers through registering their profile and qualifications in TESDA portal.

D. Technology-Based Community Training Program for Poverty Alleviation Program

Trainings are designed to address the needs for skills training of the community folks with the objectives of creating self-employment. The target individuals are underprivileged and 4P’s beneficiaries.

SERVICES
